Re: GRAMA: Police Report

Dear SLCPD Service Desk,

Pursuant to Government Records Access Management Act (GRAMA), Utah Code §63g-2-204: I am requesting a copy of the police report in reference to **Shirley Canham** a former employee of the Salt Lake City School District. Specifically, she worked at **Uintah Elementary School** located at **1571 East 1300 South, Salt Lake City**, Utah 84105 as the manager of Child Nutrition.

The School Board has been investigating an incident that occurred at Uintah Elementary on January 28, 2014, where school lunches were taken from children by child nutrition personnel and discarded in a garbage can. Following that event, the Board of Education commissioned an external investigation that was recently made public (see attached cover sheet).

At the **September 2, 2014**, School Board meeting (see enclosed minutes) one of the schools patrons reported that "the Salt Lake City Police Department [went to the] school when students, parents, and teachers were present, to ask their lunch lady to go down to the Police Department for questioning."

I was later told that the police went to the school (see address above) on **April 25, 2014** and took Shirley Canham to the police department for questioning. This incident was not mentioned in the external investigation commissioned by the Board of Education. The school district personnel have given conflicting and unreliable information as to why an employee of the school district was taken by the police. As an elected member of the Board of Education, I am attempting to understand the scope of the Salt Lake City Police department's involvement in the incident of lunches being discarded by school personnel.

Although the Squire report is a final report, Mr. Ostler's report is still a draft, and needs to be finalized. Instead of releasing the reports at two separate times, the board wants to release them together. The board's timeline is two weeks to have everything released to the public. It was clear to board members there was a multi-

B. REQUESTS TO SPEAK

- 1. Erica Lukes addressed the board on the Uintah School Lunch Investigation Reports. She said eight months later it would be nice to have answers to their questions. She said she tries to teach her children not to bully, feels the manner the district goes about business is a "bully mentality", and what has happened to Uintah's lunch lady is despicable. She asked the Superintendent who had authorized the Salt Lake City Police Department to go into their school when students, parents, and teachers were present, to ask their lunch lady to go down to the Police Department for questioning. She said she feels the district has been disingenuous, has no desire to get to the truth, and no desire to share the truth with the public. She said the parents are not going anywhere, they will be here until the issue has been resolved.
 - 2. Annie Payne addressed the board on the Uintah School Lunch Investigation Reports. She said she has spoken to a number of board members, and agrees there was a complete breakdown of communications all the way down the line. She said a year and a half ago the board was presented a proposal for a new lunch accounting system, MyPaymentsPlus. She has a hard time imagining why the board bought a \$250,000 program, but thinks the board did it in confidence that it was the right thing to do. She said she thinks the first installment of \$250,000 got the district the software, but not the part that contacts parents who have lunch balances due, yet the district thought it was all-inclusive. Uintah's lunch lady, Peggy Bjourn, and Kelly Orton all thought parents were being notified, when in fact that was not happening. She said she is concerned the district is continuing to pay MyPaymentsPlus, and urged the board to stop payments saying the district cannot afford to continue. She said nobody knew parents weren't being contacted, daily reports were not happening, but she does not feel punitive damages were targeted at the right people.
 - 3. Ashley Hoopes addressed the board on the Uintah School Lunch Investigation Reports. She thanked the board for doing an external investigation. She said Uintah's lunch lady ran the lunchroom as a "safe space". Uintah's children knew they could go to the lunchroom and receive lunch in a safe environment. She said she feels Uintah's lunch lady is having to suffer the consequences of her boss putting into place a software system that did not let parents know their account balances. She said Uintah's students are feeling the loss of this safe person, and feels this could have been avoided if the school district had taken responsibility instead of pinning the problems to a lunch worker who was just trying to do the best she could.
